

TEMPORARY TRAFFIC MANAGEMENT NOTICE, VARIOUS ROADS, WEYMOUTH

DORSET COUNCIL has issued a Notice under Section 14 [2] of the Road Traffic Regulations Act 1984 as amended. The Notice is needed in order to comply with health and safety regulations which require the provision of safe working areas and to minimise likelihood of danger to highway users. The Notice comes in to operation on 19 February 2024 between 0900 and 1600 and will remain in force for 5 days, however it is anticipated that the works will be completed by 20 February 2024.

This Notice will enable Dorset Council to carry out essential highway maintenance.

The effect of this Notice is as follows:

- [1] To impose temporary road closure on Dundee Road for its entirety
- [2] To impose temporary road closure on Dover Road from its junction with Dundee Road to o/s no. 73 Dover Road
- [3] To impose temporary road closure on Dumbarton Road between its junctions with Dundee Road
- [4] To impose temporary clearway on Dundee Road for its entirety to prevent vehicles from stopping except those associated with the works
- [5] To impose temporary clearway on Dover Road from its junction with Dundee Road to o/s no. 73 Dover Road, to prevent vehicles from stopping except those associated with the works
- [6] To impose temporary clearway on Dumbarton Road between its junctions with Dundee Road, to prevent vehicles from stopping except those associated with the

Please note that any vehicle waiting in contravention of temporary parking restrictions may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986. If a vehicle has been removed, the owner must contact the Council's vehicle recovery contractor: Ashleywood Recovery Ltd/Bride Valley Recovery Ltd on 01305 889421
