EMERGENCY TEMPORARY CLOSURE OF CHICKERELL ROAD (PART), WEYMOUTH

DORSET COUNCIL has issued a Notice under Section 14 [2] of the Road Traffic Regulations Act 1984 as amended. All vehicles will be prohibited from proceeding along CHICKERELL ROAD, WEYMOUTH between its junction with Abbotsbury Road and its junction with Roundham Gardens, a distance of approximately 120 metres. The Notice is needed in order to comply with health and safety regulations which require the provision of safe working areas and to minimise likelihood of danger to highway users.

It came in to operation on 14 March 2024 and can remain in force for up to 21 days, however it is anticipated that the works will be completed by 21 March 2024.


This Notice will enable SGN safe access to carry out emergency works to gas main.
